## Why United Way?

**Local:** 21 health and human service agencies serving Forrest, Lamar and Perry counties benefit from United Way of Southeast Mississippi's fund-raising efforts. Only 1% of money raised in the campaign goes to United Way Worldwide.

**Successful:** Raised over \$1.5 million in 2009-2010 campaign and almost \$8 million in the last five years!

**Strategic:** Local volunteers make sure your money is well spent to meet specific needs in our community.

**Important:** United Way of Southeast Mississippi funds agencies in four impact areas: education, financial stability, health and support services. United Way's community partner agencies address pressing needs in our community such as quality housing, at-risk youth, drug prevention and disaster relief services.

**Efficient:** 83% of collected funds goes to community programs and services, while about 17% is used for administration expenses, such as campaign materials.

**Accountable:** United Way of Southeast Mississippi is audited annually by an independent auditing firm.

**Trustworthy:** Formed in 1940, United Way of Southeast Mississippi has formed a reputation as an organization you can trust.

**Voluntary:** United Way encourages voluntary giving only. One hundred percent employee participation is not asked or expected. As a guideline, we encourage fair share giving (one hour's pay per month) by those who choose to participate.

**Easy:** When payroll deduction is available, it makes giving convenient and easier for employees to budget.

**Worthwhile:** Your participation will provide help, hope, opportunity and positive change in the lives of thousands in need within our community. Plus, you never know if someday you too might need the services of a United Way agency.
